MINUTES OF THE DIOCESAN ASSEMBLY OF THE DIOCESE OF PHILADELPHIA AND PENNSYLVANIA HELD ON JUNE 30, 1973 AT ST. TIKHON'S MONASTERY/SEMINARY--SOUTH CANAAN, PA.

THE DIOCESAN ASSEMBLY OF THE DIOCESE OF PHILADELPHIA AND PENNSYLVANIA *INCLUDING THE DEANERIES OF FRACKVILLE, PHILADELPHIA AND WILKES-BARRE WAS HELD JUNE 30, 1973 AT ST. TIKHON'S MONASTERY/SEMINARY, SOUTH CANAAN, PA.

An opening Molieben was served by The V. Rev. Vladimir Borichevsky of St. Tikhon's Seminary, and immediately following the delegates assembled in the seminary auditorium and the meeting was officially opened with the prayer, "O Heavenly King", at 10:40 a.m.

ELECTION OF PRESIDING OFFICERS

Fr. Vladimir Borichevsky, Lake Ariel, Pa., was nominated for the office of Vice-President. Fr. Borichevsky was elected Vice-President of the Assembly (clergy).

Mr. Paul Semanco, St. Clair, Pa., was nominated for the office of Lay Vice-President. The nomination was closed and Mr. Semanco was elected Lay Vice-President.

Fr. Joseph Martin, McAdoo, Pa., was nominated for the office of Clergy Secretary. Fr. Martin was elected.

Mr. Russell Dugan was nominated for the office of Lay Secretary and was elected to that office.

The minutes of the last meeting held on July 8, 1972 were distributed. Correction to the minutes was made. The correction was: "Fr. Fedoronko was not in attendance at the meeting." A motion was made by Fr. Slepecky and seconded by Fr. Petorak to accept the minutes with the correction. The motion was passed.

ARCHPASTORAL ADDRESS OF HIS EMINENCE, THE MOST REVEREND KIPRIAN, ARCHBISHOP OF PHILADELPHIA AND PENNSYLVANIA

Venerable Fathers and beloved brothers and sisters in Christ, Members of the Diocesan Assembly of the Diocese of Philadelphia and Pennsylvania:

CHRIST IS IN OUR MIDST!

I greet all of you on this day of our Diocesan Assembly, in our Spiritual Centre of Orthodoxy, the Monastery of St. Tikhon of Zadonsk.

Another year has passed since our last Diocesan Assembly and, thanks to Almighty God, all is in order within our Diocese.

A great event in the life of our Church and Diocese took place on 10 February: the consecration of the Vicar Bishop of our Diocese, the Rt. Rev. Herman. It was a great joy for me personally to participate in the consecration to the episcopate of my helper and partner of eleven years. It was likewise an honour for our Diocese, in which Vladyka Herman has served since his ordination. And, due to the consecration of Bishop Herman, nearly every parish in our Diocese received an episcopal visitation during this past Lenten season.

Also, on 13 May, 1973, at St. Michael's Cathedral, Sitka, I participated in the consecration of the Rt. Rev. Archimandrite Gregory Afonsky as Bishop of Sitka. It was during the March meeting of the Holy Synod that Fr. George Afonsky was nominated for consecration to the episcopate, to occupy the then-vacant See of Sitka. On 30 March, he was tonsured a monk here at St. Tikhon's Monastery by His Beatitude, Metropolitan Ireney, and given the name Gregory, after St. Gregory the Theologian. On 1 April he was elevated to the rank of archimandrite, and then the consecration itself took place in Sitka.

During February of this year, St. Herman's Pastoral School opened in Kenai, Alaska. Metropolitan Vladimir, Archbishop of Berkeley, presided at the opening ceremonies. The first semestre of the school was completed 15 May, and on that occasion were present His Beatitude, Metropolitan Ireney and His Grace, Bishop Gregory.

Important dates in the life of our Diocese included:

4 November, 1972, on which date I consecrated the renovated Church of St. Andrew in Baltimore, which had been destroyed by fire.

11 March, 1973, on which date Vladyka Herman broke ground for the new rectory of Holy Resurrection Cathedral, Wilkes-Barre.

3 June, 1973, on which date Vladyka Herman and I blessed the new rectory of St. Michael's Church, Jermyn.

24 June, 1973, on which date Vladyka Herman and I consecrated the renovated

on which date Vladyka Herman and I consecrated the renovated Church of St. John the Baptist, Edwardsville, which had been severely damaged during Tropical Storm Agnes.

Once again, on Holy Thursday, I presided at the ancient Service of Foot-Washing here at our St. Tikhon's Monastery. Present with me at the Lord's Table were Vladyka Herman and 28 priests of our Diocese.

Also at our Monastery, the annual Memorial Day Pilgrimage was held this year on 27 May, in connection with the 35th anniversary of St. Tikhon's Seminary. Besides Bishop Herman and myself, 4 other members of the Synod of Bishops were present: Metropolitan Ireney, Archbishop John (Chicago), Bishop Theodosius and Bishop Dmitri. This year's pilgrims had the opportunity to see and venerate the renowned Icon of Our Lady of Tikhvin.

Ordinations this year were as follows:

- 22 October, at St. Tikhon's Monastery, Fr. Michael Evans was ordained deacon by me.
- 29 October, at St. John the Baptist Church, Mayfield, I ordained Fr. Evans priest.
- 14 January, at St. Tikhon's Monastery, Fr. Joseph Chupeck was ordained deacon by me.
- 10 February, at Holy Resurrection Cathedral, Wilkes-Barre, Vladyka Herman ordained Fr. Chupeck to the priesthood.
- 15 April, at St. John the Baptist Church, Mayfield, I ordained to the diaconate Fr. Dennis Swencki.
- 12 May, in Sitka, Alaska, Bishop Gregory ordained Fr. Eugene Bourdukofsky a deacon.
- 20 May, at St. Tikhon's Monastery, I ordained Fr. Panteleimon to the diaconate.
- 24 June, at St. John the Baptist Church, Edwardsville, I ordained to the diaconate Fr. Theodore Boback.

Also, this past year, Fr. Joseph Gallick was released as Rector of St. Vladimir's Church, Lopez, and appointed Rector of Poly Resurrection Church, Alden Station. Fr. Michael Evans was appointed Rector of St. Vladimir's Church, Lopez. Fr. Elias Krenitsky was released as Rector of St. Andrew's Church, Dallas (17 June), and Fr. Rodion Kondratick was assigned as Priest-in-Charge for that parish (1 July).

Last September, the V. Rev. Andrew Fedec, one of the oldest priests of our Diocese, and formerly Rector of Holy Chost Church, Shenandoah, passed away. I presided at his funeral, assisted by the venerable clergy of our Diocese.

St. Stephen's Church, Philadelphia, plans to build a new temple. The court case of long standing between this parish and St. Michael's Church is now over, with the unfortunate decision that all the money collected from both sides is now the property of St. Michael's Church, and St. Stephen's Church must pay this church the sum of \$38,000. As a consequence of the same court decision, however, St. Stephen's now has property of its own on Verree Road. The faithful of this church are most dedicated and energetic, and it is our hope that, with the help of God, this parish will be able to erect a new temple in the near future. The V. Rev. Alexander Federonko is Rector of St. Stephen's Church.

We are constantly labouring for the promotion and welfare of the Diocese of Philadelphia and Pennsylvania, and that of the Orthodox Church in America. Only with the continued cooperation of the clergy and laity of our Diocese can we hope to be successful.
