MINUTES OF THE 16th DIOCESAN ASSEMBLY - SEPTEMBER 14th and 15th, 1979

GUS GENETTI MOTOR LODGE - Wilkes Barre, Pennsylvania

The 16th Annual Assembly of the Diocese of Philadelphia and Eastern Pennsylvania of the Orthodox Church in America was held on September 14-15, 1979 at Gus Genetti Motor Lodge, Wilkes-Barre, Pennsylvania. Following an Opening Molieben Service celebrated by His Eminence, Archbishop Kiprian, the Assembly was formally opened at 2:30 P.M. with the singing of "O Heavenly King."

AGENDA.

The Agenda was unanimously accepted as read upon motion by Rev. Dionysius Swencki and seconded by Rev. Rodion Kondratick.

1978 AGENDA MINUTES.

The Minutes of the 1978 Assembly were read privately. V. Rev. Daniel Donlick asked that page 2 under the Department of Missions concerning the Stroudsburg, Pocono Mission report be changed to read 7 families rather than 17 families. Upon motion made by Rev. Michael Hatrak and seconded by Rev. John Kowalczyk, the Minutes as corrected, were unanimously accepted.

The written report of His Eminence, Archbishop Kiprian is attached to these Minutes and made a part thereof.

DIOCESAN SECRETARY'S REPORT.

The written report of the Diocesan Secretary, Rev. Rodion Kondratick, is attached to these Minutes and made a part thereof. Upon motion made by Rev. Dionysius Swencki and seconded by V. Rev. Vladimir Petorak, the Report was unanimously accepted.

DIOCESAN TREASURER'S REPORT.

The written report of the Diocesan Treasurer, Rev. Paul Ropitsky, is attached to these Minute and made a part thereof. Upon motion made by V. Rev. W. B. Stroyen and seconded by Mr. Stephen Pelak, the Report was unanimously accepted.

The written report of the Diocesan Auditors, Rev. Michael Hatrak and Mr. Jerry Russin, is attached to the Minutes and made a part thereof. Upon motion made by Rev. David Lisko and seconded by V. Rev. Vladimir Petorak, the Report was unanimously accepted.

DEPARTMENT OF MISSIONS.

A written report of the Chairman of the Diocesan Department of Missions, His Grace, Bishop Herman, is attached to these Minutes and made a part thereof.

Detailed reports were given on the following Mission Parishes:

Holy Trinity Church - Stroudsburg-Pocono (V. Rev. Daniel K. Donlick)

The Mission has no property or permanent priest. Services are held in a vacant Roman Catholic Church. The heating loan of \$2,600.00 was repaid to the Diocese. The Diocese was also informed that they could discontinue the \$100.00 monthly allocation to the parish. A Building Fund has been established.

Holy Cross Church - Williamsport (Rev. Daniel Kovalak)

Divine Services are being held in the Episcopal Church. The parish now owns a parcel of ground valued at \$16,000.00 Funds are needed to construct a combination Church/Rectory. Recommendation: That a Special Mission Fund be established for the sole purpose of offering loans to newly established parishes and missions.

Following a general discussion, upon motion made by Mr. Jerry Russin and seconded by Rev. Michael Michlik the Report was unanimously accepted.

DEPARTMENT OF RELIGIOUS EDUCATION.

A written report of the Chairman of the Diocesan Department of Religious Education, Rev. Dionysius Swencki, is attached to these Minutes and made a part thereof.

V. Rev. Daniel Ressetar gave a report on his attendance at a Conference of Religious Educators in Harrisburg and of their plans for a Conference in 1981. He recommended that our Diocese be represented.

Upon motion made be V. Rev. Joseph Martin and seconded by Rev. John Adamcio, the Report and Recommendation were unanimously accepted.

DEPARTMENT OF PUBLIC RELATIONS.

A written report on the purpose and functions of the Department of Public Relations is attached to these Minutes and made a part thereof. A presentation was made by Rev. Daniel Kovalak outlining the needs of such a department within our Diocese. The presentation was favorably and enthusiastically received and many suggestions were made by the delegates for consideration by this department.

DIOCESAN CHOIR.

A written report by the Chairman of this project, V. Rev. Daniel Ressetar, is attached to these Minutes and made a part thereof.

The Diocesan Assembly reconvened at 10:30 A.M. following Divine Liturgy which was celebrated in Holy Resurrection Cathedral.

STEWARDSHIP WORKSHOP.

Rev. Daniel Kovalak gave an excellent presentation on Stewardship. He was assisted by Messrs. Don Motel and Alex Smerkanich. Rev. Michael Sekela also gave a report on the Stewards Program within his parish. The presentation was enthusiastically received with great thanks to Rev. Daniel Kovalak. The Assembly adjourned for lunch at 12:15 P.M. and reconvened at 1:30 P.M.

Upon motion made by Rev. Dionysius Swencki and seconded by Rev. Claude Vinyard, those individuals placed into nomination were unanimously elected to the Diocesan Council.

ELECTION OF THE DIOCESAN COUNCIL. (cont'd.)

It was announced that all Deans are Ex Officio members of the Diocesan Council with the right to vote.

RESOLUTIONS.

Upon motion made by Rev. Daniel Kovalak and seconded by Rev. John Kowalczyk, it was unanimously resolved that "The Diocese of Philadelphia and Eastern Pennsylvania, being deeply concerned to fulfill the divine command of Our Lord Jesus Christ to preach the Gospel of Salvation to all nations, and especially within our Diocese, establish a Special Mission Fund for the sole purpose of making loans available to newly established parishes and missions

Upon motion made by Rev. Daniel Kovalak and seconded by V. Rev. Joseph Martin, it was unanimously resolved that "The Diocese of Philadelphia and Eastern Pennsylvania formally establish a Department of Public Relations."

Upon motion made by Rev. Dionysius Swencki and seconded by V. Rev. George Pawlush, it was unanimously resolved that "The Diocese of Philadelphia and Eastern Pennsylvania promote, support, and encourage the concept of Stewardship within our Diocese."

DIOCESAN CENTER.

Rev. Rodion Kondratick made a presentation to the Assembly concerning the need to renovate the Diocesan Center which was followed by considerable discussion with regard to the work to be done, status of the building and manner in which funds will be raised for this project. A motion by Mr. Alexander Honcharik and seconded by Mr. Walter Kasian for the Diocesan Council to be empowered to act on this project was defeated. A motion made by Rev. John Adamcio and seconded by Mr. Walter Kasian to make a study concerning the necessary renovations and to convene another Diocesan Assembly as soon as possible thereafter for further action was defeated.

Upon motion made by Rev. Dionysius Swencki and seconded by Rev. Dimitri Voytilla, it was resolved that "The 1979 Diocesan Assembly approve the recommendation to renovate the Diocesan Center should a properinvestigation reveal that the property belongs to the Diocese of Philadelphia and Eastern Pennsylvania and that the Diocesan Council be empowered to implement the necessary measures to fulfill these recommendations." The resolution was accepted with one vote in opposition.

BUDGET FOR 1980.

The Budget for 1980 was presented by the Treasurer, Rev. Paul Ropitsky followed by considerable discussion.

A motion by Rev. John Adamcio and seconded by Mr. Russell Mosier to adopt a deficit budget was defeated. The amount of the deficit was \$7,000.00.

A motion by Mr. John Wansacz to increase the Diocesan Assessment by \$2.00 received no second.

Upon motion made by Mr. Roy Peckham and seconded by V. Rev. W. B. Stroyen, it was resolved that "The Diocesan Assessment be increased from \$3.00 to \$4.00 per adult member and that the Budget for 1980 be amended to indicate the increase in assessment and approved." The results of the voting was as follows: 48 in favor, 14 opposed and 1 absention.

Mr. Michael Warholick proposed an all layman committee for the Diocese, seconded by Mr. John Wansacz. The proposal was ruled out of order in view of the fact that it is not in conformity with the Statute of the Orthodox Church in America which calls for complete cooperation between clergy and laity.

PARISH ADMINISTRATION.

His Grace, Bishop Herman reviewed the chain of command to be followed in resolving parochial problems. It was also announced that all pastors are to complete the Diocesan Census as early as possible that we may have an accurate accounting of the Orthodox Faithful within our Diocese.

DATE OF NEXT ASSEMBLY.

It was resolved that the Diocesan Council set the date for the convening of the Diocesan Assembly in 1980 taking into consideration that the All American Council will also be held in 1980.

ADJOURNMENT.

Having depleted the Agenda and upon motion made be Rev. Michael Lepa and seconded by Mr. Jerry Russin, the Diocesan Assembly was adjourned at 4:30 P.M. with the singing of "It is truly meet...." A Closing Molieben was served by His Grace, Bishop Herman.
